Question	Answer
Do you fund feasibility and pilot studies?	Yes, we do. The MPS Foundation is very keen on funding applied research and research that looks at what works so feasibility and pilot studies are welcomed.
Can you be an independent practitioner researcher to apply for these grants?	The Grants are not restricted to institutions. Independent practitioners are welcome to apply for a Grant. We have already funded a number of research projects undertaken by independent practitioners.
What are the intellectual property rules of the grant?	Any intellectual property that you own at the start of the project will remain your own. The MPS Foundation wishes to ensure that the outcomes of projects are utilised for the benefit of healthcare professionals where relevant and will publicise, disseminate and promote the outcomes of your project including directly to MPS members. How IPR is applied will be dependent on how work already undertaken by the researcher(s) informs the new research undertaken with the MPS funding. The MPS Foundation will follow its Intellectual Property Right Policy in the Use and Exploitation of Intellection Property Rights which will be clearly outlined in the funding agreement.
Can an SME apply or research organisations?	Yes, an SME can apply for a grant as can a research organisation. We have already funded a number of SMEs.
What has been the application to successful application rate for past issues of the grant? ie x number of applications, y number of grants awarded.	Approximately 20% of those invited to submit a Full Application have been successful in securing a Grant over the last two years. The decision as to whether to support an application is ultimately the decision of The MPS Foundation Board. The Board focus on the quality rather than the volume of applications.

Do I have to locally get research ethical approval?	Yes, we require applicants to secure ethical approval locally as we provide funding to researchers in a number of different countries
Is the grant supporting only work in the UK?	No. Researchers can come from anywhere in the world but they must base at least 51% of their research project in one of the MPS jurisdictions which are: UK, Ireland, South Africa, Malaysia, Singapore, Hong Kong, New Zealand, Australia, Caribbean and Bermuda

Question	Answer
Do you have an ethics board to approve research?	No, we require applicants to secure ethical approval locally. Ethical approval can be applied for after submitting your final application and The MPS Foundation agreeing to fund your project. However, we expect that applicants will have considered how they will achieve ethical approval and from whom at the point of application.
Can ethics approval be obtained for studies that include patients or is better to avoid direct patient contact when planning a study?	A number of our studies involve direct patient contact and ethical approval has been obtained for these.
Will qualitative research be considered equally favourably as quantitative?	Yes, a number of our existing projects are qualitative as well as mixed methods research.
As a South African doctor can I apply for the grant?	Yes, you can
May I try to apply if I submitted a proposal last year that was not funded?	Yes, previous applicants are welcome. You will have received some feedback from last year and the Research Committee will be expecting that this has been acted upon if you are putting forward the same proposal as you did previously.
I would like to know if studying diplomas and master's is also funded.	We do not fund university fees for undergraduate or post graduate studies.
Can my research related to a master's thesis, being done in Singapore, be eligible for funding?	The MPS Foundation will fund the research element of a Master's study and has done so previously.
I would like more information about areas on interest for the foundation.	The areas of interest and our priorities are listed on our website and on the Grant Portal: The MPS Foundation Application Guide
Could we involve more than one organisation in collaboration?	Yes, we have previously had applications from collaboratives with more than one organisation
Are the MPS Foundation grant opportunities available for studies based in Kenya	The study can be based in Kenya but the research needs to involve at least 51% of subjects who are in an MPS jurisdiction
In what capacity can I be a part of the research without taking on the entire project myself?	You can create a project team to undertake the research and you don't have to do all the work yourself. The MPS Foundation will pay (using a day rate) for a project team. You can take on any role within that team.

Question	Answer
What research experience do we need?	You will need to demonstrate that you have experience of research in your team. This may not be you personally but in assessing your application the Research Committee will be looking at those supporting you to ensure that they have the relevant knowledge, skills and experience to complete the proposed project.
How much money is available?	The MPS Foundation has funded projects between £2,500 and £199,000. The maximum budget for a project is £200,000 and £100,000 in any one year. To encourage smaller projects we operate two schemes, the first scheme is for projects worth up to £60,000 and between 3 months and 36 months of duration. The second scheme is for projects between 12 and 36 months and worth up to £200,000.

We are unlikely to support a general climate change proposal as that is outside of strategic focus. A project should focus on at least one priority area. Do you fund patient and public involvement?	A small amount or something akin to a coffee voucher has been funded historically, it would need to be looked at in context of specific applications.
What is required in terms of ethical approval prior to project commencement?	Applicants are requested to secure ethical approval at their local level. At the full application stage, applicants will be asked how they are going to achieve that ethical approval, who from etc. Projects would not commence without ethical approval being confirmed.
Will the MPS Foundation fund research on occupational wellbeing of Allied healthcare trainees?	Yes
Would the MPS Foundation cover the costs of a steering group?	This would be dependent on costs and how it impacted a project.

How strict is the definition of 'research'. vs evaluation	We recognise that there can be a fine line between research and evaluation. The Research Committee will review each application on its merit and assess whether the project will elicit new knowledge and learning that can be shared with others. A straight forward evaluation of an already implemented programme is unlikely to be supported
Do you pay any overheads to host organisations?	We recognise that all organisations carry overheads, we do not pay for overheads as a budget line but will pay where a per capita amount of overheads is included as part of the calculation of the day rate.
Does the grant offer funding to hire research assistants/statistical support?	Yes
Can funding cover staff costs to hire a research assistant?	We will pay for a research assistant to be part of the project but not the staff costs to recruit that research assistant
Are the following costs fundable? - Compensation for participant time - Catering for participant workshops - Open access fees for journal publication - PPI groups	Yes - In terms of compensation for participant time we would anticipate that this will be in the form of small gratuities, often in the form of vouchers.

If successful can we use a portion of the money to pay costs for Diabetic Nurse Educators and for pathology to determine the outcomes of both our findings and then impact of interventions?	Yes. You will be asked to include these costs in your Full Application if you are successful at the Full Application stage
How broad an area are proposals expected to cover? I.e. should they aim to cover a range of specialties/settings, or would the MPS Foundation consider proposals with a narrow focus that can lead to more generalisable findings?	A difficult question to answer as it depends on the project. We would recommend that the breadth and depth of study will be determined by the outcomes and impact you wish to achieve. We already have a number of studies that are focused on specific specialities with the view that the learning can be transferred elsewhere if they are successful as the focus on one or two specialities provides greater insight for the amount of funding available.

Will MPS Foundation pay for public and patient involvement relevant to the project and any dissemination costs such as journal open article fees, or attendance and travel to conferences (incluing conference fees) etc	We will pay for patient involvement but this is expected to be a token of thanks rather than a full recompense of their time. We will pay for journal articles. The MPS Foundation expects to be kept informed of any articles that are submitted for publication and these should be shared before publication. The MPS Foundation will share the articles and the link to the journal once they have been successfully published
Are you expecting us to use references? If so, within word count? 2. Do you have a standard format/length for narrative CVs	We do not anticipate you to provide references or citations at the Expression of Interest stage. You will be asked to provide them at the Full Application stage. We do not have a standard format for a CV although we are looking at potentially providing a template in the future. We expect CVs to cover the applicants experience relevant to their role and the project. We do not require you to provide a CV that reflects more than 10 years of your professional experience unless there is something particularly pertinent to the project.
